Ill-equipped

With around 1500 prisoners and an estate of three prisons, the Northern Ireland Prison Service is a very small prison service. This inquiry was undertaken to examine whether the estate was adequate and appropriate for the secure accommodation of Northern Ireland's prisoners and whether the Prison Service meets the health, education and training needs of prisoners. One of the main conclusions is that the Current Comprehensive Spending Review does not provide sufficient capital for the substantial redesign of the prison estate. If criminal justice is to be devolved the Committee hope that capital investment in the prison estate will be a priority of the Northern Ireland Executive. If not the Secretary of State will have to argue for an increase in funding.

Drawing on a body of empirical, qualitative work spanning three decades, this unique text traces the significance of critical social research and critical analyses in understanding some of the most significant and controversial issues in contemporary society. Nutrition in Institutions

In the past 30 years, the population of prisoners in the United States has expanded almost 5-fold, correctional facilities are increasingly overcrowded, and more of the country's disadvantaged populations—racial minorities, women, people with mental illness, and people with communicable diseases such as HIV/AIDS, hepatitis C, and tuberculosis—are under correctional supervision. Because prisoners face restrictions on liberty and autonomy, have limited privacy, and often receive inadequate health care, they require specific protections when involved in research, particularly in today's correctional settings. Given these issues, the Department of Health and Human Services' Office for Human Research Protections commissioned the Institute of Medicine to review the ethical considerations regarding research involving prisoners. The resulting analysis contained in this book, *Ethical Considerations for Research Involving Prisoners*, emphasizes five broad actions to provide prisoners involved in research with critically important protections: • expand the definition of "prisoner"; • ensure universally and consistently applied standards of protection; • shift from a category-based to a risk-benefit approach to research review; • update the ethical framework to include collaborative responsibility; and • enhance systematic oversight of research involving prisoners.

Community Mental Health Services in Northern Europe

Unique in its use of a sustainability framework, *Social Welfare Policy for a Sustainable Future* by Katherine S. van Wormer and Rosemary J. Link goes beyond U.S. borders to examine U.S. government policies—including child welfare, social services, health care, and criminal justice—within a global context. This treatment program targets the criminal, behavioral, and mental health problems of inmates in segregated housing that prevents them from living prosocially and productively within the general prison population. The program makes use of a bi-adaptive psychoeducational and cognitive-behavioral treatment model to increase inmates' understanding about the psychological and criminal antecedents that contributed to their current placement, and to teach them the skills necessary for managing these problem areas. This flexible intervention assists inmates with significant problem behaviors by reducing psychological impairment and improving their ability to cope with prison life. This book includes a program introduction and guide for clinicians, the inmate workbook, and accompanying eResources to assist clinicians in both successful program implementation and evaluation of treatment outcomes. Designed to account for the safety and physical limitations that make the delivery of needed mental and behavioral health services difficult, this guide is essential reading for practitioners working with high-needs, high-risk inmate populations.

State of California Salaries and Wages Supplement

The benefit of having skilled nurses working in prisons has been noted in a recent report from the Chief Inspector of Prisons (Home Office 1998). This report recommended that the organisation of health care in prisons be made the responsibility of the NHS. This is the first book aimed specifically at nurses working in prisons. There is a specific set of skills needed to be a prison nurse. The environment is radically different to other areas of practice and the nurse-patient relationship and its boundaries are of paramount importance. This book is written by nursing experts in this field and includes chapters on women's health, ethnic and cultural issues, educational demands, the legal and political settings, prison culture, and suicide.

In the UK and elsewhere there has been growing recognition of detainee's vulnerability and the need for robust, independent mechanisms to protect them from ill-treatment. This view was given formal recognition by the United Nations when it adopted the Optional Protocol to the Convention against Torture and other Cruel, Inhuman or Degrading Treatment or Punishment (OPCAT) and its ratification by the UK in 2003. The basic premise of OPCAT is that protections for those who are detained can be strengthened by a system of regular visits to all places of detention. OPCAT requires the designation of a national preventive mechanism (NPM) to carry out such visits and to monitor treatment. The UK NPM was established in March 2009 when it was decided that the functions of the mechanism would be fulfilled by the collective action of 18 existing bodies with the HM Inspectorate of Prisons as co-ordinator. This report is the first annual report from the NPM in the

UK. It details the individual and collective activities of its members in the period 1 April 2009 to 31 March 2010. As well as providing background information on OPCAT and the role of the NPMs, it outlines the role of the individual members and their detention-related activities. The NPM also makes its first collective recommendation that the UK government identifies any places of detention not visited by the NPM and ensures that those gaps are addressed
